Companies who wish to purchase prohibited ODS from local importers for export, shall prior to export, declare the intended transaction to the Pollution Control Department. Such transaction shall be made in the **Declaration by Licenced Exporter of Controlled Ozone Depleting Substances form**.

Importers who wish to sell prohibited ODS to another company for export shall declare such transactions in a **Re-Export Debit Authorisation of Controlled Ozone Depleting Substances (ODS) form**.
